

Warranty extension Supreme Ventus® Air Control Unit Lagersmit

General

The Supreme Ventus system is an air system that compensates pressures and it drains oil and water consumption or leakage into the vessel. Because the pressure within the seal and stern tube (or thruster) are matched with the surrounding water pressure, lip seals and liner will have a minimum of wear. A well maintained air control system is key to keep the Supreme Ventus system functioning and provide Peace of Mind. Therefore, Lagersmit offers a service to renew the critical parts of the Air Control Unit ("ACU") Lagersmit has created a special service kit, to replace all vital parts and upgrade the ACU software ("SK-ACU-FULL). Upon customer's order, Lagersmit can provide this service kit and necessary service to renew the Supreme Ventus ACU. Upon renewal of the critical parts of the ACU, Lagersmit provides an extended five (5) year warranty on the ACU.

Warranty

Lagersmit's warranty obligations are strictly limited to - at the discretion of Lagersmit- either repair or replace the ACU for one time only. If necessary and in the event of leakage¹ to the outside environment Lagersmit shall provide two working days of service attendance without costs. The warranty term ends after five (5) years upon delivery, five (5) years after installation and commissioning by a Lagersmit engineer or upon the first dry-dock, whichever comes first.

Condition for warranty

The maintenance complies with all Lagersmit's checks and regulations applying on maintaining, upgrading and renewing parts of the Supreme Ventus system. Maintenance services requires the presence of a Lagersmit Service Engineer who executes the work and has commissioned the installation and proper functioning of the ACU through the Lagersmit checklist. A duly signed checklist showing approval of maintenance and functioning, should be provided to Lagersmit in case of warranty matters and is the proof of the validity of the system and correct installation. The exclusive use of Lagersmit parts or services on and to the Supreme Ventus ACU or seal is also a condition for warranty.

Exclusions

Any and all circumstances that influence the working of the seals and ACU (products delivered by Lagersmit excepted), amongst others but not limited to damage, leakage and/or failure due to:

- incorrect installation by third parties;
- maintenance by a (third) party that is not certified by Lagersmit to service its seals and systems;
- outside influences, such as ropes, fishing lines, fishing hooks, fish netsetc.;
- · injudicious use;
- failure of supportive systems to the Supreme Ventus system;
- insufficient use of corrosion prevention, not using propeller shaft-grounded equipment and/or due to inadequate maintenance of this equipment;
- changes made to the Supreme Ventus system without written approval of Lagersmit,

exclude a claim under the (extended) warranty.

Additional note for seals with SeaGuard option

In case the seal is equipped with a SeaGuard module, this should be activated first in case of abnormal leakage. Only if the seal continues to show abnormal leakage after successful activation of the SeaGuard module, a claim will be taken into consideration by Lagersmit.

Preference

In the event of any discrepancy between this document and the General Terms and Conditions of Contract of Holland Marine Equipment Association, the terms and conditions of this document shall prevail.

Lagersmit products should be installed, operated and maintained as set-out in the corresponding manual.
